

TERMS AND CONDITIONS OF ATTENDANCE AND PARTICIPATION TO

BCCL & Industrial Bank Co-Marketing Event: 2023 China's Economic Outlook and Opening-up of China Bond Market

- 1.1 The following terms and conditions shall apply and govern the attendance and participation of the registered participant (the “**Registered Participant**”) to the BCCL & **Industrial Bank** Co-Marketing Event: 2023 China's Economic Outlook and Opening-up of China Bond Market (the “**Online Conference**”). Bond Connect Company Limited (“**BCCL**”) and Industrial Bank Co., Ltd. (“**Industrial Bank**”) shall co-host the Online Conference.

2. Registration

- 2.1 By registering with the Online Conference, you, the Registered Participant, accept and agree with BCCL that these terms and conditions which are binding and enforceable upon you. If you are registering on behalf of another individual, it is your responsibility to ensure the Registered Participant is aware of these terms and agrees to them as he or she would be regarded to be so by virtue of holding the Registered Participant status.
- 2.2 Your registration allows you to access primarily to the Online Conference. You will receive essential information about the Online Conference electronically from BCCL and/or its affiliates, agents or authorized contractors, including their employees, officers, directors and representatives (the “**Related Parties**”) at the email address you provide at registration.

3. Participation in the Online Conference

- 3.1 Notwithstanding your registration, BCCL retains the sole discretion to disallow or suspend you from registering to or participating in the Online Conference. BCCL further reserves the right to deny participation to Registered Participant or anyone who engages in or is reputed to engage in unethical or non-compliant business practices.

- 4.1 You acknowledge and agree that BCCL is prevented from carrying out its obligations as it pertains to the Online Conference you registered for as a result of any cause beyond its control ("**Force Majeure Event**"), including without limitation of the impracticability of delivering any of the Online Conference owing to issues concerned with software, hardware, equipment, hosting platform, or acts of God, strikes, labour disputes, government requisitions, restrictions or wars or apparent acts of war, terrorism, disasters, civil disorders, epidemic or pandemic, curtailments or restrictions on transportation facilities, or any other comparable calamity, casualties or conditions.
- 4.2 In the case of Force Majeure Event, BCCL shall reserve the right to immediately terminate the Online Conference without liability and shall be relieved of all obligations to the Registered Participant and relevant parties. BCCL at its entire discretion may reschedule the Online Conference in which case notification would be given to the Registered Participant for re-registration.
